Tokyo Stock Exchange (“TSE”) ranked third globally and first in Asia by market capitalization in 2015 and exceeded NYSE and NASDAQ in terms of number of listed companies as of the end of 2015 with 103 initial public offerings (“IPOs”) in 2015.

Over the years, TSE has been taking measures to encourage and support the listing of foreign companies. The debut of Acucela Inc., a Seattle based clinical-stage biotechnology company, on TSE in February 2014 and the listing of SanBio Co., Ltd., a US origin regenerative medicine company, in April 2015 aroused foreign-based companies’ interest of listing in Tokyo market.

The Seminar will include presentations from TSE featuring the advantages of Tokyo IPO market and followed by representatives from Mizuho, KPMG and Morrison & Foerster who will share their insights relating to key considerations for TSE listing.
